New Business:

Non-Confidence Vote

191/10 Hasiak THAT as indicated in her email to all council members, dated April 30th 2010, Mayor Roni Goulet has chosen not to work with the rest of council on the issues facing the Village of Buena Vista in a collaborative and open manner. Mayor Goulet has indicated by her actions that she is prepared to unilaterally, and without support or consent by resolution or bylaw, work outside of council and outside of procedures and policies as set out in Section 119 subsections (1) and (2) of the Municipalities Act regarding governance and public accountability.

This is unacceptable to council and therefore a motion of non-confidence is put forth and supported by councilors Heerspink, Hasiak, Neuls and Knight on this 13th day of May, 2010. This motion indicates that a majority of council has no confidence that Mayor Roni Goulet will work in the best interests of the Village in the manner set out by law.

Mayor Goulet is also misrepresenting the opinion and directive of council as a whole, specifically at IMUC committee meetings, where it is deemed a long term, amicable relationship with Regina Beach council is being jeopardized by her continued attendance.

As a result of this non-confidence motion be it resolved that:

As of May 13th, 2010 in accordance with Section 93 subsection (2) of the Municipalities Act that ALL Committees of Council move forward without Mayor Roni Goulet as a member until such time as a majority of council rescind this resolution.

Be it resolved that:

All and any letters or emails of correspondence written by Mayor Roni Goulet to individuals, businesses, companies, corporations, Government agencies or their representatives, or other councils on behalf of the Village of Buena Vista, be circulated to all members of council for prior approval.

Be it resolved that:

All members of council including the Mayor who have a key to the Administrators office turn those keys over to the Acting Administrator immediately. The Acting Administrator, Cindy Baumgartner, will then enter a new master key code and will be solely responsible for access to the Villages Administration office.
