**2. Development Application for 1500 Grand Avenue**

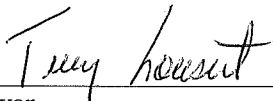
220/08 Dinu: That we approve this application to clear this lot for a garage site. CARRIED.

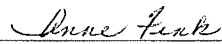
**3. Development Application for 1029 Schwann Avenue**
